STATEMENT OF WORK

Replace Windows at a Government Owned Property

Addresses: TBA, Red Hill ACT 2603, Australia

1.0 Overview

The United States Government (USG) has a requirement to remove the existing wooden window inserts and replace it with UPVC window inserts in the government owned residence at TBA, Red Hill ACT 2603, Australia.

2.0 Scope Description

The contractor will remove the existing wooden windows (about 25 windows in the main residence building and 8 windows in the guests-quarters building) and design, supply and install new white UPVC window inserts to match the existing style. Timber frames are to be refinished ready for painting. The exact number and size of windows will be identified during the site visit.

The contractor shall conduct a site visit and inspection to obtain an overview of the project and document the existing site conditions to allow for proper, measurements, cost estimating and scheduling of work. The contractor responsibilities include, but not limited to:

- 2.1 Removal of existing windows and protection of surrounding elements.
- 2.2 Prepare window frames, install new windows, and install new IGU's.
Windows are to be designed to maximize acoustic and thermal insulation. Window to have a U-Factor of ≤ 0.30 and a solar heat gain coefficient of ≤ 0.25 . Installed units should have an Air Leakage Rating of ≤ 0.3 CFM/Ft² and an STC rating ≥ 30 (or equivalent SRI rating).
- 2.3 Window style is to match existing and shall be level and plumb. Wall cavities around new windows are to be insulated to the greatest extent feasible. All timber frames are to be refinished ready for painting.
- 2.4 All new windows are to have window locks fitted alike.
- 2.5 Bathroom windows to have obscured glass fitted.
- 2.6 Existing fly screens are to be replaced on completion of the work. Existing CRIMSAFE screens can be reused if in good condition, replaced if worn or damaged (to be determined during site visit).
- 2.7 Remove all demolition and rubbish from work site daily. All finishes adjacent to the Work shall be fully protected.

- 2.8 The contractor is always to maintain all site structures in a secure, safe, and stable condition.
- 2.9 The contractor is to ensure all materials and workmanship shall be in accordance with the relevant and current Australian standard codes and with the by-laws and ordinances of the relevant building authorities.

3.0 General Requirements

- 3.1 **Contracting Officer Representative** - The contractor's primary point of contact regarding this project is the COR.
- 3.2 **Site Cleanliness** - The contractor must always maintain a tidy work site. Unsightly materials and debris should be removed at the end of each workday. Provide bins / trash containers for this purpose. Materials should be scheduled for delivery only as required for immediate use. Upon completion of work, all tools appliances, equipment, and surplus material shall be removed from the premises and unless otherwise directed, the finished work left in a neat, clean, and serviceable condition acceptable to the COR.
- 3.3 **Timeframe** – The contractor is to provide the estimated construction duration of the project. Work shall be completed in a timeframe that is agreed upon between the contractor and the COR at the time of award.
- 3.4 **Tools** - The contractor is responsible for providing all the tools and equipment.
- 3.5 **Storage** - The COR will designate a specific place for on-site storage of tools and materials. Tools and materials not installed on a given day shall be returned to the designated storage area at the end of each workday. The contractor's materials may be stored on the site at their own risk
- 3.6 **Working Hours** - Working hours shall be Monday through Friday 0700 to 1700. Other hours may be arranged with prior approval from the COR.
- 3.7 **Utility Usage** - Contractor personnel shall have use of on-site water and electricity.
- 3.8 **Warranty** - The contractor is to provide warranty details on all material and workmanship from the date of final acceptance by the COR.
- 3.9 **Safety** - The contractor is required to maintain a safe environment for US Government employees, their families, the public, and his employees. All employees of the contractor shall have the proper Personal Protective Equipment (PPE). All work shall be conducted in a manner to avoid injury. All ACT WHS work practices and applicable industry safety guidelines shall be observed.

- The Government will determine quoter responsibility by analyzing whether the apparent successful quoter complies with the requirements of FAR 9.1, including:
 - adequate financial resources or the ability to obtain them;
 - ability to comply with the required performance period, taking into consideration all existing commercial and governmental business commitments;
 - satisfactory record of integrity and business ethics;
 - necessary organization, experience, and skills or the ability to obtain them;
 - necessary equipment and facilities or the ability to obtain them; and
 - be otherwise qualified and eligible to receive an award under applicable laws and regulations.

ADDENDUM TO EVALUATION FACTORS
FAR AND DOSAR PROVISION(S) NOT PRESCRIBED IN PART 12

The following FAR provisions are provided in full text:

52.217-5 EVALUATION OF OPTIONS (JUL 1990)

The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. Evaluation of options will not obligate the Government to exercise the option(s).

52.225-17 EVALUATION OF FOREIGN CURRENCY OFFERS (FEB 2000)

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7).
